GUIDELINES FOR AUTHORS

Full-length original research papers presented at the *Trends in Nanotechnology 2004 conference* will be considered for inclusion in a Special Issue of *Nanotechnology*. Please note that only those papers that fit in the scope of the journal will be considered for the special issue.

The journal aims to publish papers at the forefront of nanoscale science and technology and especially those of an interdisciplinary nature. Here, nanotechnology is taken to include the ability to individually address, control, modify and fabricate materials, structures and devices with nanometre precision, and the synthesis of such structures into systems of micro- and macroscopic dimensions such as MEMS based devices. It encompasses the understanding of the fundamental physics, chemistry, biology and technology of nanometre-scale objects and how such objects can be used in the areas of computation, sensors, nanostructured materials and nano-biotechnology.

Submission guidelines are given below: please send your paper electronically directly to IOPP by **20 September 2004**. You are welcome to send your papers before the conference. **Only those papers received before the deadline of 20 September 2004 will be considered for inclusion in the special issue.**

Once received, your paper will be assessed by the Guest Editors of the issue who will decide on the suitability of the paper for the scope of the issue. It will then be refereed according to the usual standard of quality for the journal.

Each paper considered for the issue will be refereed to the usual standards of quality for the journal. Publication date, assuming deadlines are met, is **May 2005**. Papers will be published online as soon as they are ready, in advance of the print version.

In addition to the manuscript, please complete **an Article Submission Form and an Assignment of Copyright form** (see below or download from <http://www.iop.org/journals/authors>). In particular, please note the point concerning the reproduction of material already published elsewhere. Please send your **Article Submission form and signed Copyright Form together with the article** to IOP via web or by e-mail as indicated below.

How to submit electronically

There is no need to supply hard copies of the manuscript to IOPP, provided that it has been prepared according to these guidelines. Please submit all components necessary to generate a complete printed version of your article together with any other media enhancements. **Please remember the submission deadline is 20 September 2004.**

Web:

This is our preferred method of submission: users of Netscape (version 2 or higher) or Internet Explorer (version 4 or higher) can submit using the online submission form at **www.iop.org/journals/authorsubs**. Please complete the form, use the 'Browse' button to select your article's single compressed file and the 'Transfer' button at the bottom of the form to submit your file. Please indicate that it is a submission for '**TNT04 special issue**'.

E-mail:

A single compressed file containing an archive of your submission information (*readme.txt*), text and graphics files should be sent, as an attachment where possible, to the journal's e-mail address (**nano@iop.org**) with the words '**Submission for TNT04 special issue**' in the subject

line. Please do not send each of your text and graphics files as separate e-mails as this causes a considerable delay in processing your submission.

How to archive and compress your files

Text and graphics files should be archived and then compressed into a single file for ease of handling and to save time and space. The following compression or archiving programs may be used: WinZip, PKZip, tar + gzip, arj, lha, uc2, uuencode, compress, StuffIt or Zipit. Please name the resulting file *filename.ext* where the first four characters of *filename* are the first four characters of your surname and the last four are the current day and month in MMDD format (e.g. smit0531) and .ext is an extension (maximum three letters) denoting the file type (e.g. .zip for a PKZip file, .sit for a StuffIt file, .uu for a uuencoded file). If you have any difficulty archiving your files, please contact us for assistance (esub@iop.org).

NB: Microsoft Word documents and the output files from most compression utilities are binary files and must be encoded using uuencode, binhex or MIME before being sent by e-mail. Your e-mail system may do this automatically, but if it does not, or if you are unable to encode your submission in one of these ASCII formats, you must send your submission by FTP or on disk instead. Some e-mail systems have a file size limit, for example 100 Kbytes; if this is the case for your e-mail system, files that are larger than 100 Kbytes after compression should not be split into multiple parts, but should be sent using the online submission form, FTP or on disk. Acknowledgement of electronic submissions:

Successful receipt and processing of your electronic submission will be manually acknowledged by the Electronic Services Specialist by e-mail when your submission has been checked. If you do not receive this notification within one week then you should contact the Electronic Services Specialist (esub@iop.org). You will receive further acknowledgement shortly afterwards from the Publishing Administrator when your article has been assigned a reference number.

File preparation

The text of the article can be prepared using Microsoft Word or any common variant of TeX. For more details visit www.iop.org/journals/authors.

Adobe Acrobat PDF: Acrobat PDF format is only suitable for the refereeing process. If you are able to supply a PDF file for your article at this stage it will speed up the assessment of your article. Please note **Acrobat PDF is not suitable for the production process**. You will be asked to send the text of your article in its original source form as it reaches the production stage.

Figure formats

Our preferred graphics formats are vector Encapsulated PostScript (EPS) or PostScript (PS). These files can be used directly to give high quality results and file sizes are small in comparison with most bitmap forms. Most graphics software has the facility to save or export as EPS.

Multimedia

Video clips and animation

Acceptable formats for video or animation clips are MPEG (we recommend MPEG1), QuickTime (we recommend Cinepak codec for compression, and Quality 100%), Windows AVI or Animated GIF (use only standard GIF functions as some browsers do not support the whole GIF standard).

Multimedia files should be submitted (preferably in compressed form) at the **same time** as the original article.
